

KEY OPERATING POINTS AND FEATURES

- A: Pan lock with reference scale and Allen key lock-off
- B: Tilt lock with reference scale and Allen key lock-off
- C: Spot lid locking clip
- D: Ventilation slots.

These vents must be unobstructed at all times

- E: Accessory holder (3 slots allows various size accessories) Front accessory slot accepts the barn door or snoot
- F: Potentiometer shaft for dimming option.



The Philips Selecon Accent LED Beamspot has a built-in transformer to convert from your local voltage.

PAN TILT ADJUSTMENT



Adjusting the pan angle Release the set screw above the ballast box (as shown) and adjust accordingly. Re-lock after adjustment.



Adjusting the tilt angle
The tilt can be adjusted by
unlocking the hex screw located as
shown. Re-lock after adjustment.

DALI Version

Accent LED Beamspot models with local dimming **CANNOT** be installed and run on a dimmed power supply/track.

Accent LED Beamspot Dali models with no local dimmer can be installed and run on a DALI track system. .

If your Accent LED Beamspot model includes a local dimmer, ensure that the dimming knob on the Accent power supply is at its "Full" position (completely clockwise) to test fitting.

Keep your Accent LED Beamspot in top condition and performing at its best by cleaning it regularly with a soft cloth.

The above is the only maintenance task that can be safely carried out by non approved personnel.

Philips Selecon has manufactured this luminaire in accordance with recognised best practices to recommended international safety standards. It is your responsibility to maintain this luminaire in good and safe working condition.

Repairs should only be carried out by suitably qualified persons. Do not operate the luminaire with damaged lamps or cables, etc. Consult your Philips Selecon distributor for assistance. Only replace damaged parts with authorised Accent spare parts.

N.B. Luminaire electrical cable – your Accent LED Beamspot is fitted with special heat resistant flexible cable, replace with genuine Accent spare part cable kit only – please refer to your Selecon distributor.

(Replacement cable kits are supplied complete with necessary terminal connectors).

ELECTRICAL INSTALLATION

WARNING!!!

Risk of fire and electric shock. This product is to be installed by a qualified electrician only. This luminaire employs a grounded type receptacle and is not intended for connection to a two-wire, ungrounded source of supply.

When installing this luminaire use wire conductor colour codes as follows:

Brown - Phase, Live

Blue - Neutral, Return

Green/Yellow - Earth

LIMITED WARRANTY

Philips Selecon warrants its fixtures against defects in materials or workmanship. The term of this warranty is based on the product usage and is from the date of delivery.

Usage: Architectural, Display Term - Three Years

Architectural, Display relates to typical usage such as display lighting in a Museum viz: 10 – 12 hrs per day, seven days per week.

This warranty is void in any of the following circumstances: (a) The fixture has been misused, neglected, damaged or abused. (b) The fixture has been improperly installed, operated, repaired or maintained. (c) The fixture has been modified. (d) The fixture has been connected to other equipment with which it is not compatible. (e) The fixture has been used or stored in conditions outside its electrical or environmental specifications. (f) The fixture has been used for purposes other than for which it was designed. (g) The fixture has been used outside its stated specifications and operating parameters.

Correct installation of the luminaire is the owner's responsibility.

To assert a warranty claim, complete the Philips Selecon Return Authorisation Form (available from Philips Selecon). Return the luminaire to Philips Selecon or its authorised agent.

If Philips Selecon accepts the warranty claim, Philips Selecon will provide, or arrange for, service, repair or replacement as Philips Selecon shall determine in its sole discretion. Philips Selecon shall bear the cost of such service, repair or replacement. However, the owner shall bear the cost of freight and insurance on the luminaire, both ways. If Philips Selecon does not wish to service, repair or replace the defective luminaire, it shall refund the purchase price.

Philips Selecon's sole responsibility is to repair, replace or service a luminaire subject to a valid warranty claim. Under no circumstance will Philips Selecon be liable for direct, indirect, incidental, special or consequential costs or damages, including dismantling and re-installation costs, loss of operations or profits, to the maximum extent permitted by law.
